#### ACQUIRE TITLE, INC.

#### ARTICLE I - NAME:

The name of this corporation is Acquire Title, Inc., (hereinafter referred to as the "Corporation").

ARTICLE II - DURATION:

The Corporation shall exist perpetually, commencing September 1st, 2003, which is the date of subscription and acknowledgment of these Articles of Incorporation.

#### ARTICLE III - PURPOSE:

The general nature of the business to be transacted by this corporation is to manufacture, purchase, or otherwise acquire, and to own, mortgage, pledge, sell, assign, transfer, or otherwise dispose of, and to invest in, trade in, deal in and with, goods, wares, merchandise, real and personal property, tangible and intangible, and services of every class, kind and description; and to conduct any other business and carry on any other activity as may be permissible under law; except that it is not to conduct a banking, safe deposit, trust, surety, express, railroad, canal, telephone, telegraph, or cemetery company, a building and loan association, fraternal benefit society, state fair, nor exposition.

The Corporation is authorized to issue 1,000 shares of One Dollar (\$1.00) par value common stock.

# ARTICLE V - PREEMPTIVE RIGHTS:

Every shareholder, upon the sale for cash of any new stock of the Corporation of the same kind, class, or series as that which he or she already holds, shall have the right to purchase his or her pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price which it is offered to others.

#### ARTICLE VI - INITIAL PRINCIPAL OFFICE, REGISTERED OFFICE AND AGENT:

The street address of the initial principal office of the Corporation is, 32 East Highway C-30A, Suite 203, Grayton Beach, Florida, 32459 and the mailing address is the same as above. The street address of the initial registered office of the Corporation is the same as above, and initial registered agent of the Corporation at that same address is Jared Bradley.

#### ARTICLE VIII - INCORPORATOR:

#### ARTICLE IX - BY-LAWS:

The power to adopt, alter, amend, or repeal By-Laws shall be vested in the Board of Directors and the shareholders.

It is the intent of this charter that the Director(s) may sell the capital stock of the Corporation in accordance with the conditions of Sections 1242-1244, inclusive, of the Internal Revenue Code of 1986, as amended.


