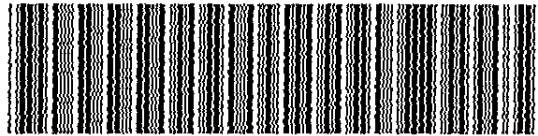

ARTICLE I

NAME



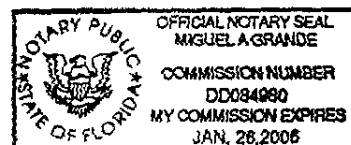
