ARTICLE I - NAME

The name of this corporation is JITC Group, Inc.

ARTICLE II - PURPOSES

The general nature and purposes of business to be transacted, promoted and carried on by the corporation are as follows:

- a. To supply Healthcare Facilities with temporary nurses who are certified with all or one of the following credentials: RN, LPN.
- b. This corporation will not be limited to only placing Registered Nurses or Licensed Practical Nurses, but will have the ability to place other healthcare professionals in available positions as outlined by facilities with which the corporation has a contract.
- c. Placement of healthcare professionals will vary in duration depending on the requirements of the contracted facility or healthcare institution.
- d. To do everything necessary and proper in accomplishing the purposes herein set forth and to do anything incidental thereto which is not forbidden under the laws of the State of Florida.

ARTICLE VIII - SEVERANCE & TERMINATION OF EMPLOYMENT
