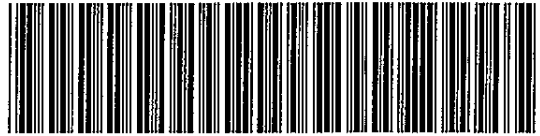

OF

ARTICLE I. Name. The name of the corporation shall be: ROCK CITY ASSOCIATES, INC.

ARTICLES II. Principal Office. The principal office of business is : 5515 West Irlo Bronson Highway, (192), Suite 2, Kissimmee, Florida 34746.

ARTICLE III. Purpose. The corporation is organized in compliance with Chapter 607 and/or Chapter 621, Florida Statutes and the purpose for which the corporation is organized is:

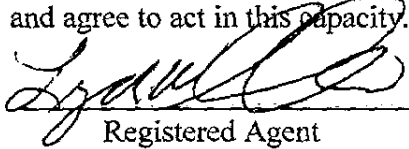
