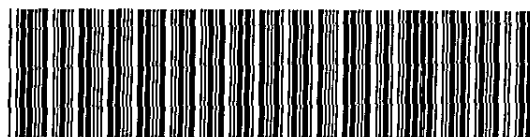

ARTICLE I

Name of Corporation

The name of this corporation shall be: --

Corporate existence will commence on the date of the filing of these Articles of Incorporation and shall exist perpetually.


