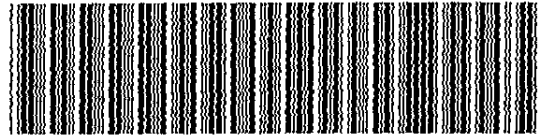

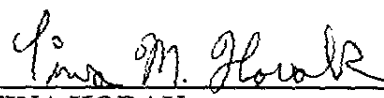
The power to adopt, alter, amend or appeal by-laws shall be vested in the stockholders.

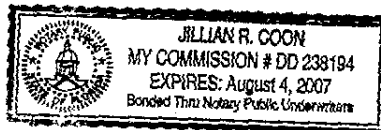
