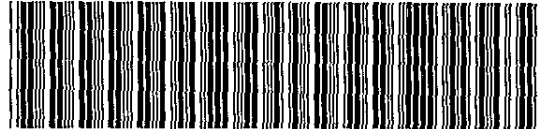




ARTICLE VII

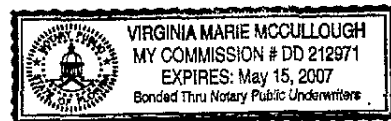
