ARTICLES OF INCORPORATION
OF

The undersigned, for the purpose of forming a corporation under the Florida Corporation Act, hereby adopts the following articles of incorporation:

ARTICLE I

The name of this corporation shall be SOUTHERN MASONRY OF INDIAN RIVER COUNTY, INC., hereinafter referred to as the "corporation".
