**AMENDED AND RESTATED ARTICLES OF INCORPORATION
OF
KANBAR CONSULTANTS, INC.**

Kanbar Consultants, Inc. (the "Corporation") filed its original Articles of Incorporation with the Florida Department of State on August 28, 2003, effective as of August 27, 2003 (the "Original Articles"). These Restated Articles of Incorporation and the amendments to the Original Articles as contained herein were duly adopted, effective March 15, 2007, by the entire Board of Directors of the Corporation and all shareholders of the Corporation, being a sufficient number of votes for approval, in accordance with Sections 607.1006 and 607.1007 of the Florida Business Corporation Act.

ARTICLE I - NAME

The name of the Corporation is KANBAR CONSULTANTS, INC.

ARTICLE II - ADDRESS

ARTICLE VII - BYLAWS


The power to adopt, alter, amend or repeal Bylaws shall be vested in the Board of Directors and the shareholders.


