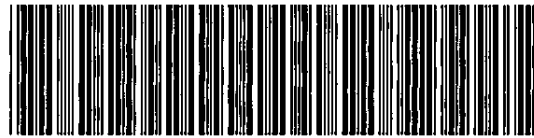

ARTICLE VI.


There are no actions pending against the Corporation.

The effective date of the adoption by the Directors, Shareholders and Officers of the above mentioned Dissolution is July 31, 2007.


