**THE UNDERSIGNED** subscriber to these ARTICLES OF INCORPORATION, being a natural person competent to contract, does hereby forms a corporation for profit under the law of the State of Florida.

#### ARTICLE I NAME

THE NAME of the corporation shall be ABILITY PLUS, INC.

#### ARTICLE II PURPOSE

This corporation may engage in or transact any and all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

#### ARTICLE III CAPITAL STOCK
