The name of the corporation is Brigitte A. Semexant, D.O., P.A.

ARTICLE II - DURATION

The corporation shall have perpetual existence commencing on the date of filing.

ARTICLE III - PURPOSE

The corporation may engage in the practice of Medicine and any Healthcare related activity or business permitted under the laws of the United States and the State of Florida.
