#### ARTICLE VIII. MERGER AND CONSOLIDATION.

The approval of a majority of the shareholders of this corporation to any plan of marger or consolidations shall be required in every instance, whether or not such approval is required by law.

# ARTICLE IX. DIVIDENDS.
