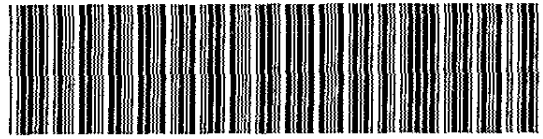



ARTICLES OF INCORPORATION

OF

JOHN PAUL FAMILY CORP.

ARTICLE I

The name of the corporation is JOHN PAUL FAMILY CORP. (hereinafter called the "Corporation"), and the address of the principal office and the mailing address of the Corporation is 221 W. Oakland Park Boulevard, Fort Lauderdale, FL 33311.

ARTICLE II

This corporation may engage in any activity or business permitted under the laws of the United States and Chapter 607, Florida Statutes.

ARTICLE III

The capital stock authorized, the par value thereof, and the characteristics of such stock shall be as follows:
