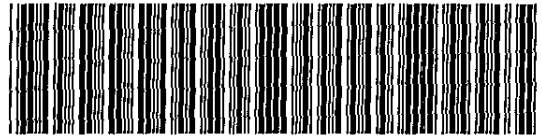

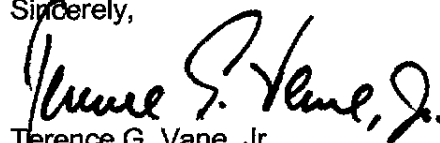

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation is Dental Temps of Northwest Florida, Inc.

ARTICLE II. PRINCIPAL OFFICE

The street address of the principal office of the corporation is 11 Driftwood Avenue, S.W., Ft. Walton Beach, Florida 32548.

ARTICLE III. GENERAL PURPOSE

The general purpose for which the corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

**ARTICLE IV. CAPITAL STOCK**

The aggregate number of shares which the corporation shall have authority to issue is One Thousand Shares (1000), of a par value of One Cent (\$.01) per share, all of which shares shall be designated common shares. 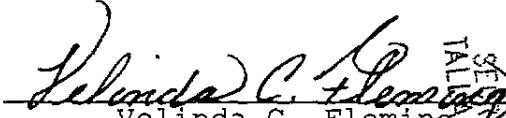

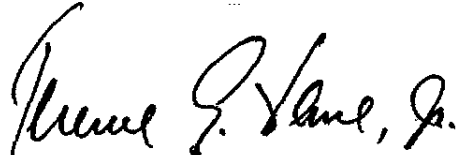
