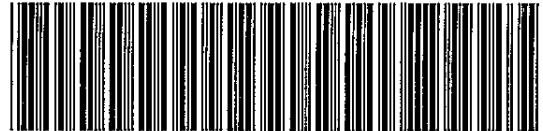

**ARTICLE I.**

**NAME OF CORPORATION**

The name of the corporation shall be: ADEKA NETWORK DESIGNS, INC.

**ARTICLE II.**

**PRINCIPAL OFFICE**

The initial principal place of business and mailing address of the corporation shall be:

**ARTICLE III.**

**CAPITAL STOCK**

The corporation shall have a perpetual existence.

## **ARTICLE VII.**

### **INITIAL REGISTERED OFFICE AND AGENT**

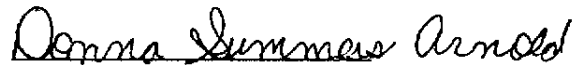
ARTICLE IV.
