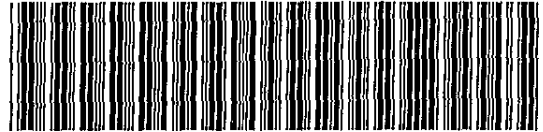

ARTICLES OF INCORPORATION

ARTICLE I NAME

The name of the Corporation is: DBT SERVICES, INC., a domestic corporation which is not a member of any affiliated group.

ARTICLE II PRINCIPAL OFFICE

The principal place of business of this corporation shall be: 107 North Branch Road West, Ruskin, Florida 33570.

The principal mailing address of this corporation shall be: 107 North Branch Road West, Ruskin, Florida 33570.

ARTICLE III PURPOSE

The general purposes for which the Corporation is organized are:

1. To engage in the business of handyman services to the public; and
2.
