The undersigned Subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation is

OAK ROSE FARM, INC.

EFFECTIVE DATE

ARTICLE II - DURATION

The existence of this corporation is to begin on the 1st day of September 2001 and to continue perpetually thereafter.

ARTICLE III - PURPOSE

This corporation is organized for the primary purpose of owning, managing and operating an equestrian breeding, raising, and related services and facilities business. In addition, this corporation may engage in every phase of any and all activities or businesses permitted by the laws of the United States and of the State of Florida or any other state, territory, district or possession of the United States and all such activities or business as may be permitted in any foreign country.
