With this letter we are submitting our formal request for the waiving of penalties associated with the late filing of the Uniform Business Report for the year 2005 for Tommy's Custom Furniture, Inc.

We never receive renewal reminders or correspondence from the Division of Corporations regarding our status. In early May of this year, our accountant discovered that the reason why we didn't get mail from the State was that the address on records for our registered agent was not complete. We went ahead and submitted on 05/23/05 the 2005 for Profit Corporation Annual Report (UBR), accompanied by our check # 1482 in the amount of \$150.00 and mailed to P.O. Box 6198, Tallahassee, FL 32314. This time the report had our registered agent's correct address. Our check also had in the memo section, the reference UBR-2005 and our employer federal identification number.

According to our accountant Mr. Orlando A. Ramos, E.A., the check referenced above still shows outstanding to 08/31/05, and our local bank has not clear the check up to September 21st, which gives the indication that the form along with the check got lost somewhere between the Postal service's office and Tallahassee.

The company that provided the service to incorporate the business changed ownership and does not assume responsibility for submitting the incorporation papers with an incomplete address. We've been left alone with the burden to pay a penalty not borne from our acts, first, because of an incomplete address and second, because our renewal documents along with our check got lost somewhere.
