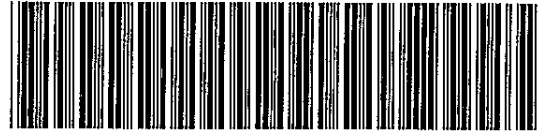

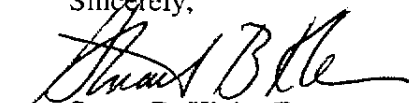

ARTICLE I

The name of the corporation is EXPEDIENT RECOVERY SERVICES, INC. The principle office and mailing address is:

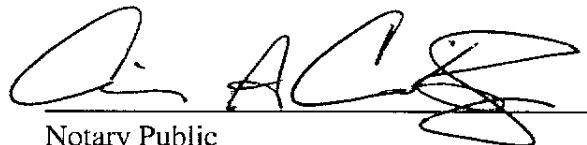

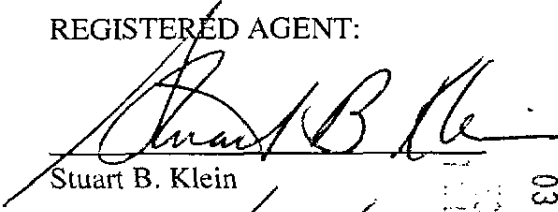

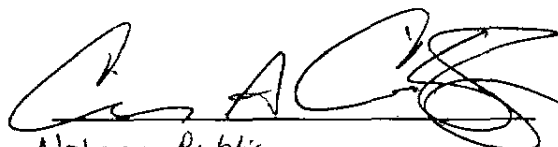
