



ARTICLES OF INCORPORATION

OS SER JO PROVIDENCE

OF

RGAMEZ MANAGEMENT, INC.

The undersigned, acting as the Incorporator of RGAMEZ MANAGEMENT, INC. a Florida corporation (the "Corporation"), pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for the Corporation:

ARTICLE I - NAME

The name of the Corporation is RGAMEZ MANAGEMENT, INC. The mailing address of the Corporation shall be 510 Golfpark Drive, Celebration, FL 34747.

ARTICLE II - CORPORATE EXISTENCE

The Corporation will exist commencing on the date of filing these Articles of Incorporation with the Florida Department of State.

ARTICLE III - DURATION

The Corporation shall exist perpetually.

ARTICLE IV - PURPOSE

The Corporation is organized for the purpose of transacting any or all lawful businesses for which corporations may be incorporated under Chapter 607, Florida Statutes.
