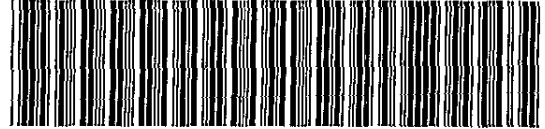

The undersigned, Sixto J. Junco who is a citizen of the United States, desiring to form a corporation, for profit, under the General Corporation Laws of the State of Florida, hereby certifies that:

ARTICLE I: The name of the corporation shall be Pacer Investments, Inc.

ARTICLE II: The place where its principal office is to be located is 3840 Maule Road, Pensacola, Escambia County, Florida.

ARTICLE III: The purpose of said corporation is to engage in any lawful act or activity for which a corporation may be formed in Florida.

ARTICLE IV: The maximum number of shares the corporation is authorized to have outstanding is one hundred (100), of which all shall be designated as "common shares", have a par value of one (\$1.00) dollar, and be fully paid and non-assessable.
