The undersigned Incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

#### **ARTICLE I NAME**

The name of the corporation shall be PINE ISLAND OFFICE PARK, INC.

#### ARTICLE II PRINCIPAL OFFICE

The street address of the principal office is 2916 Buttonwood Key Court, St. James City, Florida 33956, and mailing address of this corporation shall be 2916 Buttonwood Key Court, St. James City, Florida 33956.

SCOTT MYERS, and his address is 2916 Buttonwood Key Court, St. James City, Florida 33956, and the designated agent by his signature hereon, does hereby declare that he is familiar with and accepts the duties, responsibilities and obligations as registered agent for said corporation pursuant to the provisions of Section 607.0501, Florida Statutes.

#### ARTICLE V INCORPORATOR

#### ARTICLE VI DIRECTORS

The number of the directors constituting the initial Board of Directors of the corporation are three (3), and thereafter the number of directors shall be such number as is fixed from time to time by the by-laws.
