ARTICLES OF INCORPORATION

OF

Strategic Building Concepts & Consulting Inc.

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as an incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I NAME

The name of the corporation shall be **Strategic Building Concepts & Consulting Inc.**

ARTICLE II DURATION

The existence of the corporation shall begin on acceptance of these Articles of Incorporation by the State of Florida, and shall have perpetual existence.

ARTICLE III PURPOSE

The purpose of this corporation is to engage in the transaction of any and all business permitted under the laws of the United States and this State.

ARTICLE IV PRINCIPLE OFFICE
