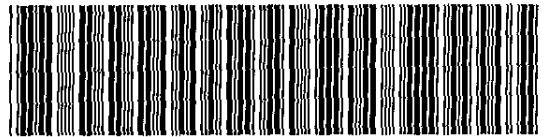

ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is DISPLAY DEPOT USA, INC., and the principal address and principal place of business is 12839 STANWYCK CIRCLE, TAMPA, FLORIDA 33626.

ARTICLE II - REGISTERED OFFICE AND AGENT

ARTICLE VI- AMENDMENTS


