

ARTICLES OF INCORPORATION
OF
GRAWUNDER ASSOCIATES, INC.

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is GRAWUNDER ASSOCIATES, INC., and the principal address and principal place of business is 2240 BELLEAIR ROAD, SUITE 160, CLEARWATER, FLORIDA 33764.

ARTICLE II - REGISTERED OFFICE AND AGENT
