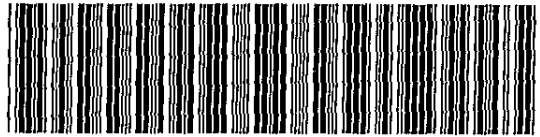

The undersigned acting as incorporator of this corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for such corporation:

**ARTICLE I - NAME OF CORPORATION**

The name of this corporation shall be Worldwide Trading Consultants, Inc.

**ARTICLE II - PRINCIPAL OFFICE**

The principal place of business/mailling address is 11001 Schooner Way, Windermere, FL 34786

**ARTICLE III - GENERAL PURPOSE**

The general purpose for which this corporation is organized shall be:

1. To manufacture, construct, purchase or otherwise acquire and to own, mortgage, pledge, sell, assign, transfer or otherwise dispose of, and to invest in, trade in, deal in with products, goods, wares, merchandise, real and personal property and services of every kind, class, and description.
2. To, organize, equip, and manage a business for the purpose of advising clients on investments.
3. It is intended that this corporation is organized for and may conduct and transact any or all-lawful business authorized and not prohibited by Chapter 607, Florida Statutes, as the same may be from time to time amended. Provided, however, and notwithstanding the generality of the foregoing, this corporation is not to conduct a banking, safe deposit, trust, insurance, surety, express, building and loan association, mutual fire insurance association, cooperative association, fraternal benefit society, state fair or exposition business.

**ARTICLE IV - CAPITAL STOCK**

The maximum number of shares of capital stock that this corporation is authorized to issue and have outstanding at any one time is Twenty Five Thousand (25,000) shares of common stock having a par value of One Dollar (\$1.00) per share.

**ARTICLE V - INITIAL REGISTERED OFFICE AND REGISTERED AGENT**

The initial street address of the registered office of this corporation in the State of Florida will be 11001 Schooner Way, Windermere, Florida 34786.
