Pursuant to Section 607.1006 of the Florida Statutes, the undersigned corporation hereby adopts these Articles of Amendment to its Articles of Incorporation:

- 1) The name of the corporation is B.S. Holding, Inc.
- 2) B.S. Holding, Inc. filed its Articles of Incorporation with the Department of the State of Florida on September 4, 2003.
- 3) Article I of the Articles of Incorporation is hereby amended and replaced in its entirety, as follows:

"The name of the Corporation shall be "B.R.S. Holding, Inc."
- 4) The Amendment to the Articles of Incorporation set forth in Section 3 above was adopted on December 31, 2011.
- 5) The Amendment was approved by a majority of the Shareholders of the Corporation. The Shareholders' number of votes cast for this Amendment is sufficient for approval.
