ARTICLE I.

The name of the corporation is: DALTON & CARPENTER, P.A.

forms a corporation under the laws of the State of Florida.

ARTICLE II.

The general nature of the business to be transacted by this corporation is to engage in the business of : To engage in every phase and aspect of the business of rendering the same professional services to the public that a duly licensed attorney under the laws of the State of Florida is authorized to render, but such professional services shall be rendered only through officers, employees and agents who are duly licensed under the laws of the State of Florida to practice law therein.
