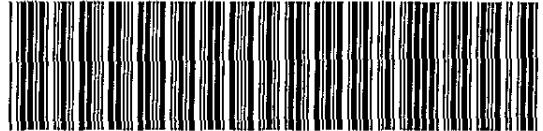

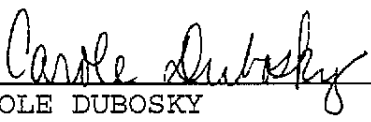
ARTICLE IX
