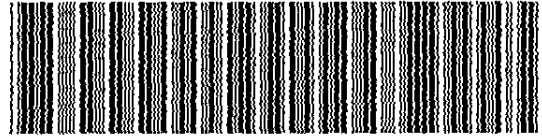

ARTICLES OF INCORPORATION

OF

ARTICLE I - NAME

The name of this Corporation is THE MED MART, INC.

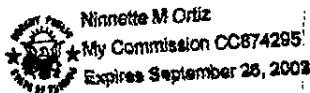
