ARTICLE OF INCORPORATION
OF

ARTICLE 1 - NAME

The name of this corporation is CLIFFORD & CLIFFORD CORPORATION, INCORPORATED.

ARTICLE II - DURATION

This Corporation shall have perpetual existence, unless sooner dissolved in accordance with the laws of the State of Florida.

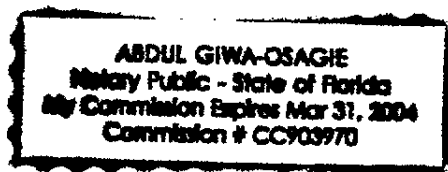
