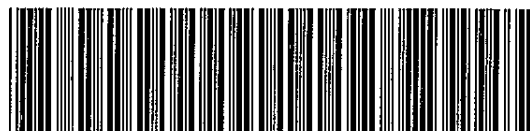

The undersigned, for the purpose of forming a corporation under the Florida Professional Services Corporation Act, does hereby adopt the following Articles of Incorporation:

Article 1. NAME. The name of the Corporation is: **ROBERT K. TRAUTMAN, P.A.**

Article 2. DURATION. The duration of the Corporation is perpetual.

Article 3. PURPOSE. The purpose for which the Corporation is organized is to engage in, perform and provide any type of personal service rendered by Real Estate Sales person under Chapter 475 Florida Statutes. No other purpose limits this general purpose in any way, and to do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish them.

Article 4. CAPITAL STOCK. The aggregate number of shares which the Corporation is authorized to issue is 8,000 shares of common stock. Such shares shall be of a single class and shall have a par value of \$1.00 per share.

Article 5. INITIAL PRINCIPAL OFFICE. The principal address as well as the street address of the Initial Principal Office of the corporation is 4208 Virginia Avenue, Sebring, FL 33875.

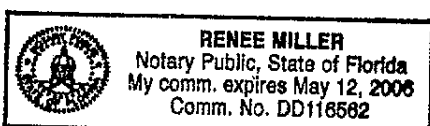
