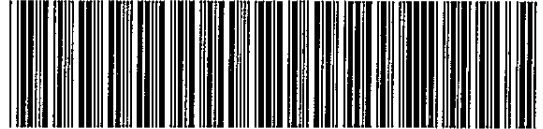

The name of the corporation is WEEDPRO, INC.

ARTICLE II. DURATION

This corporation shall exist perpetually.

ARTICLE VIII. INCORPORATOR



This corporation shall commence corporate existence on the filing date of the Articles.



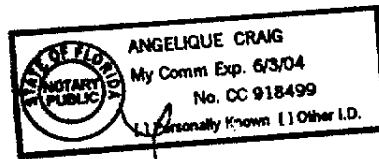
