

ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, being duly licensed to practice law under the laws of the State of Florida, adopts these articles to form a corporation under the Professional Service Corporation Act, Florida Statutes Chapter 621, and other laws of the State of Florida.

ARTICLE I - NAME

The name of the professional service corporation shall be David W. Spicer, P.A., located at 3920 RCA Boulevard, Suite 2000, Palm Beach Gardens, Florida 33410.

ARTICLE II - PURPOSE

The profession service corporation is formed to engage in every phase and aspect of the practice of law. In addition, the corporation may invest the funds of the professional service corporation in real estate, mortgages, stocks, bonds, or any other type of investment, and own read and personal property necessary for the rendering of professional services.

ARTICLE III – TERM OF EXISTENCE

ARTICLE VII – RESTRAINT ON ALIENATION OF SHARES

The shareholders of the professional service corporation shall have the power to include in the bylaws, adopted by a majority of the shareholders of the professional service corporation, any regulatory or restrictive provisions regarding the proposed sale, transfer or other disposition of any of the outstanding stock of the professional service corporation by any of its shareholders, or in the event of the death of any of its shareholders.
