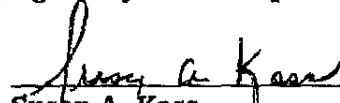

Articles of Incorporation**

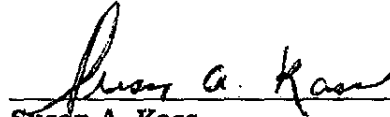
This entity is formed under the *Florida Business Corporation Act*, Chapter 607 of the *Florida Statutes* by the filing of these articles of incorporation with the Department of State.

1. **Name.** The name for this corporation is *Thirty-Nine Enterprises, Inc.*, a Florida business corporation.
2. **Initial Principal Office.** The street address of the initial principal office is 887 Garrison Drive, St. Augustine, Florida 32092. That street address is the mailing address of this corporation.
3. **Authorized Shares.** This corporation is authorized to issue 100 shares of common voting stock. This stock will have a par value of \$1 per share.
4. **Preemptive Rights.** This corporation elects to have preemptive rights as provided in Section 607.0630 of the Act.
5. **Initial Registered Office and Initial Registered Agent.** The street address of this corporation's initial registered office is 887 Garrison Drive, St. Augustine, Florida 32092. The name of its initial registered agent at that office is Susan A Kass. The initial registered agent has signed at the end of these articles to make her statement of acceptance as required by *Florida Statutes* Section 607.0501(3).
6. **Incorporator.** The name and address of the incorporator is Susan A. Kass at 887 Garrison Drive, St. Augustine, Florida 32092.
7. **Oral Notice.** Oral notice to shareholders, to directors, and to officers is authorized if it is reasonable under the circumstances.
8. **Shares Without Certificates.** The board of directors may authorize the issuing of some or all of the shares without certificates as permitted by Section 607.0626 of the Act.
9. **Effective Date.** The effective date of these articles is the date upon which they are accepted by the Department of State.
