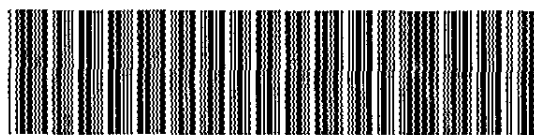

ARTICLES OF INCORPORATION

OF

GARAGES BY DESIGN, INC.

ARTICLE I – NAME

The name of this corporation is GARAGES BY DESIGN, INC.

ARTICLE II – DURATION

This corporation is to have perpetual existence.

ARTICLE III

The nature of the business of this corporation shall be to engage in any lawful business allowed under the laws of the State of Florida, and shall have all of the powers enumerated under Florida Law.

ARTICLE IV – CAPITAL STOCK

The capital stock of this corporation shall consist of one thousand shares of common stock having a nominal or par value of Fifty Cents (\$.50) per share. Property or labor may also be purchased with the capital stock at such valuation as shall be fixed by the directors.

ARTICLE V – INITIAL CAPITAL

The amount of the capital with which this corporation shall begin business is not less than five hundred (\$500.00) dollars.

ARTICLE VI – PREEMPTIVE RIGHTS

The shareholder of the corporation shall have preemptive rights as to any unissued or treasury stock on a pro-rata basis.

ARTICLE VII – INITIAL PRINCIPAL OFFICE

The street address of the initial principal office of the corporation shall be 2283 Pine View Circle, Sarasota, Florida 34231.

ARTICLE VIII – REGISTERED AGENT

The name and address of the initial registered agent of this corporation is ROBERT F. CRUM, 2283 Pine View Circle, Sarasota, Florida 34231.

ARTICLE IX – ACCEPTANCE OF REGISTERED AGENT

ARTICLE XIV – AMENDMENT


