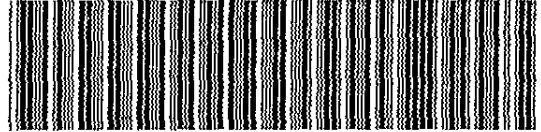

ARTICLE I - NAME

The name of this corporation is Beach to Bay Pressure Washing, Inc.

ARTICLE II - DURATION AND PRINCIPAL OFFICE
