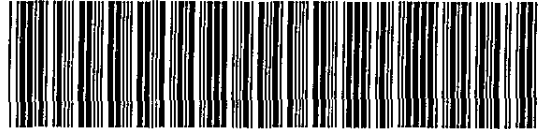

Name of Corporation. The name of this corporation shall be C' Kruse Yacht Corporation and the principal corporate office and mailing address is 1520 S. Lodge Drive, Sarasota, Florida 34239.

ARTICLE TWO

General Nature of Business. This corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida for which corporations may be organized under the laws of the State of Florida.






