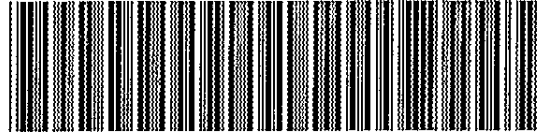

ARTICLES OF INCORPORATION  
OF

ARTICLE I - NAME

The name of this Corporation is CANITA CORP.

This Corporation shall have perpetual existence commencing




