The undersigned natural person, who is licensed to practice law in the State of Florida, hereby forms a professional corporation in accordance with the Florida Professional Service Corporation Act, and hereby adopts the following articles of incorporation for such corporation.

ARTICLE I - CORPORATE NAME AND PRINCIPAL OFFICE

The name of this corporation is DAWN E. LARSH, P.A., and its principal office and mailing address is 12815 Emerald Coast Pkwy, Suite 124, Destin, Florida 32550.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PURPOSE AND POWERS

This corporation is organized for the purpose of the practice of law. ARTICLE VIII - BY-LAWS

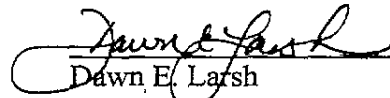
The power to adopt, alter, amend or repeal the by-laws of this corporation shall be vested in the board of directors and shareholders.

ARTICLE X - AMENDMENT

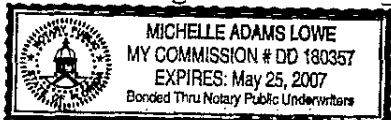

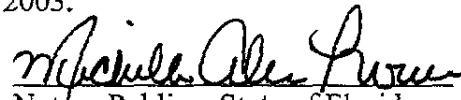

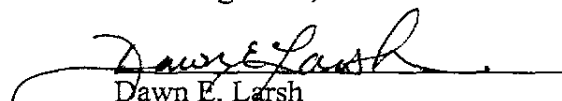
