# ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION

OF

## ARCHITECTURAL EDGE EAST, INC.

Architectural Edge East, Inc., a Florida corporation (the "Corporation"), under its corporate seal and through its incorporator, and pursuant to Section 607,10008. Florida Statutes adopts the following Articles of Amendment to its Articles of Incorporation:

### ARTICLE I

### ARTICLE II
