**ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION
OF
ARCHITECTURAL EDGE EAST, INC.**

Architectural Edge East, Inc., a Florida corporation (the "Corporation"), under its corporate seal and through its incorporator, and pursuant to Section 607.10006, Florida Statutes adopts the following Articles of Amendment to its Articles of Incorporation:

ARTICLE I
