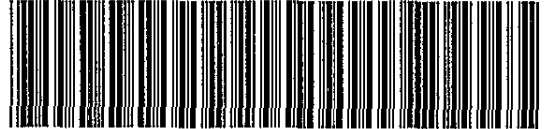

ARTICLES OF INCORPORATION

In compliance with the requirements of Fla. Stat. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

Article I NAME

The name of the Corporation is SUNSET ENTERPRISES INTERNATIONAL, INC.

Article II ADDRESS

Article III PURPOSE

The Corporation shall have perpetual duration. The purpose of the Corporation shall be to engage in and transact any lawful business for which corporations may be incorporated under the Florida Business Corporation Act. The Corporation shall also do such other things as are incidental to the purposes of the Corporation or necessary or desirable in order to accomplish such purposes.

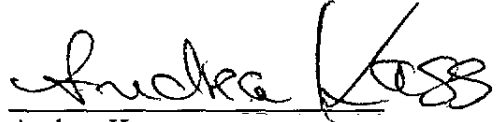
Article VIII
