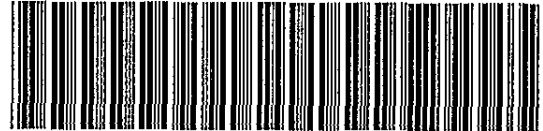

The undersigned incorporators, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following Articles of Incorporation:

**ARTICLE I**  
**NAME**

The name of the corporation shall be: Paul Dial's Home Inspection Services, Inc.

**ARTICLE II**  
**Principal place of business and mailing address**
