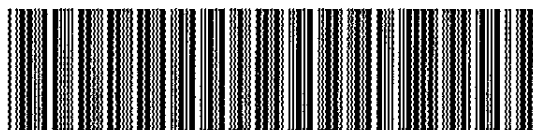



I, Wayne A. Perry, being of legal age do hereby authorize the formation of a corporation under the laws of the State of Florida.

**ARTICLE I**

The name of this corporation shall be **JHW CONSTRUCTION, INC.**


