You will note from reviewing the enclosed Annual Report that I have recently updated my business address and have received no forwarding mail from the State.

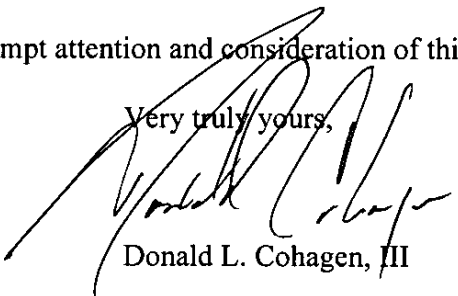
