## ARTICLES OF INCORPORATION OF

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

### ARTICLE I. NAME

The name of this corporation is: G. A. Cintron & Company, PA.

### ARTICLE II. NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation shall be: to engage in and carry on any activity or business permitted under the laws of the United States and the State of Florida in the field of accounting and finance, and to have and exercise all of the powers conferred by the laws of the State of Florida upon corporations formed there under, and to do any or all things hereinbefore set forth as principal, agent, or otherwise, either alone or in conjunction with others, and in any part of the world.

## **ARTICLE XIII. OFFICERS**




