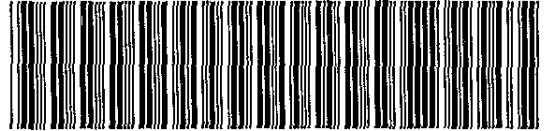




These Articles of Incorporation shall be effective upon approval by the Secretary of the State of Florida.

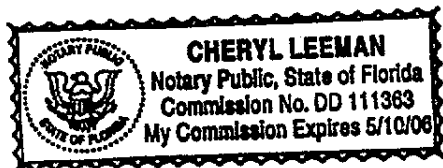


