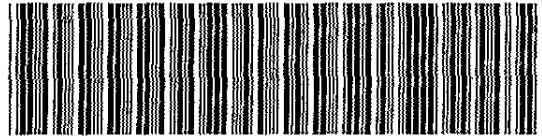

**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this corporation is LINCOLN LAND INVESTMENT, INC. located at 1682 Hibiscus Blvd., Melbourne, FL 32901.

ARTICLE III - PURPOSE

ARTICLE XIII – AMENDMENT


